### MODULE I

**Introduction to the new EU legislation on the processing of personal data**

**10:00 – 11:45**

**Objectives:** The module aims to provide a general framework with reference to the purpose of the reform on the main changes in the new European legislation on personal data protection. In particular, the first part of the module will focus on the general principles underlying the new personal data law:

- freedom of expression and information;
- the processing of personal data as a fundamental right (Articles 8 and 11 of the EU Charter of Fundamental Rights and Article 8 of the European Convention on Human Rights).

The second part of the first module will focus on:

- Scope of EU Regulation 679/2016: territorial scope and material scope
- Information on the lawfulness of the processing of personal data
- Consent
- Treatment of particular categories of personal data
- The processing of personal data in the case of criminal convictions and offenses
- The processing of personal data that does not require identification

**Expected results:** legal basis and foundations of the new reform.



**MODULE II**  
**Rights of the data subject**

**Objectives:** the module will focus on the rights of the data subject to the processing of personal data introduced

by EU Regulation 679/2016.

In particular:

- Transparency and information;
- Access to personal data;
- Right of access by the data subject;
- Right to rectification. Right to erasure ('right to be forgotten'). Right to restriction of processing. Notification obligation;
- Right to data portability;
- Right to object and automated individual decision-making;
- Automated decision making concerning individuals, including data profiling;
- Restrictions.

**Expected results:** greater awareness of the principles and tools to protect citizens and consumers in the protection of personal data.

**MODULE III**  
**Data Controller and the control activities**

**Objectives:** the module will be dedicated to the role of the Data Controller in relation to responsibilities, to the identification of the representatives of the data controllers or data controllers not established in the EU.

The module will also focus on the registers of treatment activities and on the cooperation of control activities.

In particular:

- General obligations:
- Responsibility of the controller
- Data protection by design and by default
- Joint controllers
- Representatives of controllers or processors not established in the Union
- Processor
- Processing under the authority of the controller or processor
- Records of processing activities
- Cooperation with the supervisory authority

**Expected results:** greater awareness of the professionals involved in the processing of personal data and control activities, for a better understanding of the management and possession of sensitive data.



**MODULE IV**  
**Security of personal data**  
**16:15 – 17:45**

**Objectives:** the module focuses on the levels of security in the processing of personal data by Regulation 679/2016 and the methods for handling a personal data breach. In particular:

- Security of processing
- Notification of a personal data breach to the supervisory authority
- Communication of a personal data breach to the data subject

**Expected results:** greater awareness to the management of risks and violations of personal data and the role of the supervisory authorities for the protection of citizens and consumers.
