# Transfers of personal data to third countries or international organizations 11:45-13:30

**Objectives:** the module will focus on the transfer of personal data to third countries or international organizations, with reference to the general principles governing the transfer procedure (adequacy principle) and international

cooperation for the protection of personal data, with an in-depth study on the transfer and / or communication

of personal data not authorized by Union law.

### In particular:

- General principle for transfers
- Transfers on the basis of an adequacy decision
- Transfers subject to appropriate safeguards
- Binding corporate rules
- Transfers or disclosures not authorised by Union law
- Derogations for specific situations
- International cooperation for the protection of personal data

**Expected results:** greater awareness of the relationship between the European Union and third countries and the modalities of international cooperation on the processing of personal data.

**Objectives:** the module will focus on the down the rules relating to the protection of natural persons with regard to the processing of personal data by competent authorities for the purposes of the prevention, investigation, detection or prosecution of criminal offences or the execution of criminal penalties, including the safeguarding against and the prevention of threats to public security.

**Expected results:** harmonization between the Regulation 2016/679 and the Directive 2016/680 and greater awareness of the instruments for the protection of personal data.

#### **MODULE XII**

Data protection impact assessment and prior consultation 16:15 – 17:45

**Objectives:** the module will focus on the management of the processing of personal data by the data controller in connection with the supervisory authority.

In particular, the module will focus on the procedures introduced by Regulation 679/2016 of impact assessment and prior consultation, in the event that, before proceeding to treatment, circumstances arise from which risks may arise for the data subject to the treatment.

The topics addressed:

- Data protection impact assessment
- Prior consultation

**Expected results:** greater awareness of the preventive procedures for the processing of personal data, carried out by the data controller and by the supervisory authorities.
